Description: The proposed ordinance approves and releases the RTA 2023 Annual Comprehensive Financial Report (ACFR).

7c. Ordinance authorizing an intergovernmental agreement with Service Boards to fund a Regional Day Pass (RDP) pilot

Description: The proposed intergovernmental agreement (IGA) with Chicago Transit Authority (CTA), Metra, and Pace Suburban Bus (Pace) authorizes the Executive Director to advance a Regional Day Pass (RDP) fare pilot with CTA, Metra, and Pace (collectively the Service Boards) at a cost not to exceed \$1,000.000.

Description: The proposed ordinance authorizes the Executive Director to execute a firm fixed-fee, eighteen-month contract with Resource Systems Group, Inc. (RSG) to develop and administer a Customer Satisfaction Survey.

Description: The proposed ordinance authorizes the Executive Director to enter into a contract with NearMap US, Inc. (NearMap) for subscription services to provide seamless, high-resolution aerial photography for GIS mapping and other spatial-related applications. The contract term is three years with two 1-year option periods.
